SHDC's Corner

Utility/Electric Rate Reduction--The City of Seattle will hold a public hearing on public utility rates October 1. SHDC will advocate for an extension of the City's existing very low income rate reduction program to individuals who would be eligible but for the fact that they do not live in individually metered buildings.

Right to Purchase-- SHDC is generally supporting a City of Seattle proposal to help preserve Section 8 projects. It would apply to projects where the owner wants to sell (not to opt-out situations) and would give 90 days for a tenant organization, nonprofit, or other buyer who agrees to keep the project affordable in perpetuity, to come up with earnest money and an offer to purchase. However, SHDC would like to see the ordinance define affordable at a standard lower than 80% of median, since that level is market rate! And, additional subsidy resources will be needed.

Housing Our Community Campaign---\$100 million for the State Housing Trust Fund. SHDC is an active participant in a statewide multi-year effort to increase the State Housing Trust Fund. Each year the State receives twice the amount of project funding requests as the amount available. Except for a \$4.7 million increase last year, the Housing Trust Fund has been frozen at the same \$50 million for the last four biennia and no adjustment for inflation! With Section 8 contracts expiring, an embarrassing lack of decent farmworker housing, and the homeless children's lawsuit settlement looming, the existing \$54.7 million is inadequate to meet the state's basic housing needs. The Washington Low Income Housing Congress, the Washington State Coalition for the Homeless, and the Washington Low Income Housing Network adopted a three-party resolution creating the campaign. No on Referendum 49-- SHDC opposes Referendum 49 on November's ballot. A careful examination shows that it will reduce the motor vehicle excise tax used for transit and transfer over \$400 million from the State's General Fund to back bonds for road improvements. The State will consequently have far less funding available for "discretionary" programs, including housing and human services.

AHAB Goes for \$100 million

The State Affordable Housing Advisory Board is sending its top three priorities to the Governor for the upcoming legislative session. They include:

Strengthen the State Housing Trust Fund

- Bring it to \$75 million this biennium and to \$100 million in the following biennium.
- Provide a separate \$5 million/biennium dedicated fund for farmworker housing for the next 10 years.

Strengthen Housing Finance Commission resources

- Increase the HFC debt limit to \$2.5 billion.
- Raise housing's initial share of the State's bond cap to 45%.

Assure accountability for the Buildable Lands Inventory

- Adopt Oregon's approach and allow expansion of the urban growth boundary if there is not a 20-year supply of buildable land.
- Provide incentives to increase densities within the urban growth boundaries.

AHAB members were told by State OFM and Governor's staff that any recommendation of more than a few million for the Housing Trust Fund would not be perceived as "credible." Nevertheless, AHAB members took stock of the current demand on the Housing Trust Fund and huge housing needs statewide, and proceeded unanimously to put forth the \$100 million figure.

Help Protect Fair Housing Act Standards

Efforts by local suburban cities to restrict siting of group homes for kids or people with special needs have been waylaid for now-- but advocates expect the issue to return again next year.

The federal Fair Housing Act was under fire by H.R. 3206, which would expand cities' regulatory authority over homes for children, the elderly and disabled. The bill was introduced by the National League of Cities, and was supported locally by Edmonds, Mercer Island, Bellevue and Auburn, among others. The measure almost made it out of committee, but concerned groups were able to plug into a national effort and thwart the legislation.

From February through June, Chris Heaton of The Children's Alliance was in the center of the crossfire. Grassroots efforts combined with powerful lobbyists for children's issues, the disabled and a few housing groups raised awareness in the other Washington through many calls, meetings and sign-on letters. The final sign-on letter was signed by more than 350 major organizations. The groups and individuals created the Coalition to Preserve the Fair Housing Act, which has a website at www.bazelon.org/cpfha/cpfha.html (you can still sign-on your support at this time).

Unfortunately, Heaton thinks that an amended version of the legislation will be advanced again by the NLC, perhaps as soon as January. In the meanwhile, the Coalition is working to diffuse tension around group home siting issues through a national conference in Washington, D.C. this November and a HUD-sponsored national task force this fall and winter to include cities, counties and housing providers.

Section 8 Preservation

The Section 8 Local Response Project has retained the consultant team of Mike Sivia and Pat Williams to do financial modeling of what it will take to preserve at-risk projects. About 10 representative projects will be analyzed, drawn mainly from Snohomish and King Counties, but several from Farm Home and smaller community areas also will be included. The report, due December 20, will contain financial options and policy/rule changes which could be implemented by key funding partners. The project is sponsored by SHDC, LISC, Seattle, Snohomish County, the Tenants Union, Children's Alliance, and Washington Low Income Housing Network.
