# PHG's David Colwell Building Nearing Completion

On May 10, 2000, **Plymouth Housing Group** will celebrate the opening of the David Colwell Building. You can see the building under construction at the intersection of Denny, Stewart and Yale, a few blocks from the REI flagship store.

The building is named in honor of the Rev. David Colwell, formerly Senior Minister of Plymouth Congregational Church. In the late 1970s, members of the downtown church became concerned about the increasing numbers of homeless people on the streets of Seattle – including people who slept in the church's doorways. They acted on David Colwell's words from the pulpit: "One homeless person is one too many!" and established Plymouth Housing Group as an independent non-profit in 1980.

The Colwell Building will provide 126 studio and one-bedroom apartments. Seventy-six studios will be affordable to tenants with incomes at or below 50% of median. Twenty-five of these studio units will be affordable to tenants with incomes at or below 30% of median, with five being set-aside units for people living with AIDS. Twenty-five onebedroom apartments will also be affordable tenants with incomes at or below 30% of median, with funding from **Seattle Housing Authority** through the Holly Park replacement program. Seattle Housing Authority will also provide subsidies for these very-low-income units. Tenants will come from existing PHG buildings, as well as from the community.

The Colwell Building development team includes PHG, **Stickney Murphy Romine Architects**, development consultant **Williams & Associates**, and **MarPac Construction**. Predevelopment funding was provided by the **Washington Community Development Loan Fund**. Development funders include the **City of Seattle**, City Light, **Federal Home Loan Bank**, **Washington Mutual Bank**, the **National Equity Fund**, and **Seattle Housing Authority**.

An opening celebration will be held from 12 noon to 3 p.m. on Wednesday, May 10. Mayor Paul Schell will be joined by other speakers representing the City and public and private funders, as well as the PHG board and Plymouth Congregational Church members. At the opening, PHG will also present two pieces by artists Stuart Keeler and Michael Machnic of IXL: a sculpture recognizing donors to a campaign in David Colwell's honor, as well as a tribute to David and his wife, Catherine.

# A Farewell Note from Rob

I am of course really excited about the chance to spend so much time in Japan, studying traditional architecture and housing there. During my visit to Kyoto last spring, I was struck by the special beauty that characterizes that city, and applied for this scholarship to explore not only what gives it such a special feel, but also to look for specific qualities and lessons that I might later use in Seattle, or even in China, where I spent a year before coming to HDC. So needless to say the chance to do all that at the Japanese government's expense is quite a treat!

I will be at Kyoto University, one of the premier architecture schools in the country. (If anyone remembers the first HDC article I wrote last spring, on a groundbreaking lowincome, open-design housing project in Osaka, I will be studying with the professor who helped design and develop it.) Professor Takada's "Housing Lab" focuses not only on developing new housing solutions, but also on how to adapt Kyoto's traditional housing designs for a more modern age.

Before I leave, I want to thank everyone in HDC that I have worked with this year. I have learned a great deal from you during my time here, and am grateful for everyone who took the time to explain things to me sometimes over and over! I have enjoyed working with all of you, and wish you the best in all you do. Keep up the great work! And if anyone happens to find himself in Japan in the next two years, look me up! Best wishes,

# Our World Village – A New Zoo Perspective

#### (The following is adapted from an article in the "Pan African Zoo Association Bulletin".)

"In order to simplify the world market, in which our zoological institutions exist, let's shrink the earth's population to a village of precisely 100 people. With all the existing human ratios remaining the same, it would look like this:

- 57 would be Asians, 21 Europeans, 8 Africans, and 14 from the western hemisphere, both north and south;
